I didn't have a formal report in time for the meeting as you know, so I winged it. When asked about a price range, I tossed out \$700-900 which, in hindsight, was a bit low. I have modified that in the written version and trust this won't be an issue of record-tampering since the question was asked after I completed my report.

Clearly, I should have been better prepared. Bad Melanie!

Anyway, I have done some research and have selected a potential candidate to replace the existing laptop.

I assume the following:

- There is a currently active subscription to anti-virus software; this can be transferred to the replacement machine
- The Club has a legal copy of Microsoft Office Home and Office (Word, Excel, Outlook, and Powerpoint) that is NOT OEM (in other words, it didn't come preinstalled on the existing laptop, which would limit its installation to the laptop on which it was installed at time of purchase), which can be transferred to the replacement laptop; if not, we will need to purchase at cost of \$220 on Amazon
- The Club has a legal copy of QuickBooks which can be transferred to the replacement laptop (this is typically just a matter of re-downloading from the Intuit website using your license number)
- The Club has a cloud-based backup subscription which can be transferred to the replacement laptop (I have not been advised of what system was finally decided upon so am out of the loop)

My apologies for failing to cover all of this prior to the meeting. Honestly, it just slipped my mind. Kate has been doing way too good a job for QuickBooks or the process of streamlining procedures or anything else to hit my radar.


Computer Committee Report Submitted by Melanie Hodgdon, Computer Committee Chair

# DEYC Annual Meeting August 27, 2022 Treasurer's Report

I would first like to congratulate and applaud those members in attendance today for giving up part of the waning August days to exercise their responsibility as members of the Down East Yacht Club. Maybe I should not give you too much credit because the option of "walking the plank" was, after all, the alternative. I also want to thank you and all the current members from a social and fiscal viewpoint for your spirit during the ongoing pandemic these last three years in supporting the club by your participation in the many events run by the club and by your membership dues. Much like the other area nonprofits, our club relies on the continuum of a solid membership to pay our rising inflationary expenditures.

Before I launch into the numbers of my report, I would like to salute Commodore

Jeanne Koenig for her affable, energetic, principled, and compromising leadership at
the helm during another difficult year. I can attest firsthand that Jeanne has always
exercised purposeful leadership throughout her term for the good of the club. Both
Jeanne and I were blessed to have Former Commodore Ron Richardson as our mentor.
I also would like to congratulate our Administrative Assistant, Kate Winslow, for her
upbeat and positive attitude and her overall superior work in replacing "the legend,"
Jane Mulholland. Not only has Kate successfully managed our books but also she has
worked to develop some new systems that should benefit the way we manage our
budget. In renewing your membership in the coming weeks, I trust you will place a
value on the service of the aforementioned individuals and others, including the Bridge
and the Board and various committee members who work selflessly for all members of
the club.

Now for the numbers: Unlike my beloved Red Sox this year, the DEYC has had a strong bullpen in the late innings, in the name of "Fidelity Investments," to bail us out financially during the later days of our fiscal season. As you can see from the Cliff Notes version of the budget to date, as of August 10, 2022 our revenue total is

presently \$36,632.50 based on 209 paying membership units and a withdrawal of \$4500 from our reserves/investments (\$2500 less than last year) for budgeted events and rising expenditures. The Total Operating Expenditures YTD, including all events and The Ship's Store, is \$38,525.67. This leaves us with a present deficit of \$1893.17 with a few days to go in our fiscal year ending August 31, 2022.

Some observations concerning the fiscal shortfall of our budget this year:

- While we increased dues from \$120 to \$150, we did not reach our conservative goal of adding just 5 membership units to our year-end total of 220 in 2021.
   Presently, our total paying member units is 209, as previously stated, resulting in a loss of \$2400 in prospective revenue.
- 2. Our expenditures grew by over \$2000 due to rising costs of running the club.
- Fortunately, under the careful and astute stewardship of Freeman Etheridge, the club's investments have weathered the constant fluctuations in the market with a value of \$85,438 at the end of July.
- 4. As our costs continue to increase and we continue to withdraw from our reserves without adding any surplus to bolster those reserves, we need to find ways to increase our membership numbers. Not only would this provide added revenue to our budget, but also we would be able to end our fiscal year with a healthy checkbook to begin September. This dilemma is a too-often occurrence at this time of year until the invoices go out for dues.
- 5. The Board and I are presently working together to find ways to enhance our overall revenue and decrease our costs, while at the same time still providing all the great benefits that our club has offered over the years.

# Notes for talking points Board meeting New ByLaws

- Finance Committee meeting to review cost to club
- Fiscal year ends 31 August and new fiscal year commences 1 September.
- End of fiscal year reports required by AA and Treasurer
- Cost continue and bills still incoming, no revenue between end or year and haul out part in Sept. cost however continue.
- In the past the shortfall was covered by transfer from Fidelity Account
  - o Cost to club 22% in tax effect
  - o Fidelity 7/31 down about 20% for high of \$106k
- Developed BYLaw Change to change billing of dues period
- Prior ByLaw provided for late fee but no indication of amount.
- Proposed by law includes late fee amount for standardization

## Read proposed By Law.

The Annual dues notices will be presented on or before **15 September** of each year for payment no later than **15 October**. Any membership unit whose annual dues are not paid by **15 October** shall be notified that its membership will be terminated if payment is not received by **15 November**. A late fee of 15% of dues owed shall be assessed after **15 October** 

# **Current by law**

Section 2. Annual dues notices will be presented in October of each year for payment no later than 30 November. Any member whose Annual dues are not paid by 30 November shall be notified that their membership will be terminated if payment is not received by 31 December. A late fee, determined by the Board of Director's shall be assessed after 30 November.

### Recommendation to board

As recommended by the Finance committee and Treasurer, we are hereby recommending a change in the By-Laws to reflect a change in the dues procedure. This is a BY Law Change and therefore has to be adopted/approved by the Board, Rules Committee and finally at the next available annual meeting of the membership for a vote.

# Notes for talking points Board meeting New ByLaws

As we indicated in our presentation and minutes, currently there is not any income from 1 September (new Fiscal year) until dues required to be paid in on the 30<sup>th</sup> of November. Therefore in the past, in order to pay our bills, the AA has had to request a transfer of funds from our Fidelity account. All this delay is due to the wording of the ByLaws which dictates the procedure.
